INDEMNITY FORM

To be signed by ALL guests

This RECREATIONAL ACTIVITY RELEASE AND INDEMNITY AGREEMENT is voluntarily and knowingly entered into by the persons as signed hereunder, hereinafter GUEST, and WITKLIPFONTEIN GAME FARM and its owners, guides, employees, agents, volunteers, officers, and directors hereinafter collectively referred to as the PROVIDER. This document is a full release and indemnity agreement whereby GUEST is releasing and indemnifying PROVIDER from all inherent and real dangers and risks that are associated with game reserves and / or game lodges, arising from the presence of wild and dangerous animals, reptiles, birds and insects and the real risk of bodily harm, sickness, personal injury, death and / or damage to property which may arise as a result of an encounter with the aforementioned creatures, and / or various recreational activities including, but not limited to; Game drives, Bush walks, Horse Riding, Mountain biking, Swimming on WITKLIPFONTEIN GAME FARM premises and any other activity organised by WITKLIPFONTEIN GAME FARM,

The participation in the activities at WITKLIPFONTEIN GAME FARM is purely voluntary. No one is forcing the GUEST to participate and the GUEST elects voluntarily to participate in spite of the risks.

After thoroughly reading and familiarising myself with the above,

I wish to record as follow:

1. warrant that I am 18 years of age or older.
2. acknowledge that I am well acquainted with, and fully aware of the real danger and risks that are associated with game reserves and / or game lodges, arising from the presence of wild and dangerous animals, reptiles, birds and insects and the real risk of bodily harm, injury, death and / or damage to property which may arise as a result of an encounter with the aforementioned creatures, and / or the particular circumstances prevailing on a game reserve or a game reserve environment.
3. confirm that I fully appreciate the nature of the risks that I will be exposed to whilst participating in abovementioned activities whether accompanied by an agent, guide or employee of the PROVIDER or not.
4. furthermore acknowledge that it is a condition of admission that guests with children accept full responsibility for the actions and safety of the children under their control.
5. accept that all matters arising from, or in connection with this document, its validity, existence and operation, shall be determined in accordance with the Laws of the Republic of South Africa.

THEREFORE after making of such statements as recorded above, I declare: I, for myself, my heirs, successors, executors, and subrogates, hereby knowingly and intentionally waive and release,

I, the undersigned hereby expressly confirm that I have thoroughly read and understand the above form of indemnity, all contents of what is stated, and declares that I willingly and voluntarily entered into above agreement with the PROVIDER and accept all of the provisions as stated above. I declare that there is absolutely no part of this form that I do not understand and appreciate.
